Entry Fees: £13 for a single session. Double sessions (B&C only) subject to availability at £22

Rules: Archery GB Rules of Shooting will apply, and AGB cards must be shown

Faces: All Compounds - 3 spot faces. Other archers may choose to shoot a single or 3 spot face.

Targets: 4 archers, shooting in 2 details on foam bosses.
Target List and additional information will be shared via email 48 hours before the event

Awards: Made on single sessions only; if shooting in more than 1 session, your score will be taken from your 1st session. Separate awards for the 'Open Category'

Closing Date: 23.59 pm on 18th January (or when full) 80% Refunds up to and inc. 4th January

Payment: The tournament will be strictly limited to 10 bosses. Entries MUST be accompanied by a **TICKET PURCHASE from the Warwick SU** site before a place will be allocated. If no space is available, we will operate a waiting list but only until the closing date.
